The work place is rugged, brushy, and steep. In the summer, if it were not for the black flies holding you down, the mosquito's would up and carry you off. Wild life encounters are common. We try not to hurt the bears, but the squirrels can be very aggressive. Driving and walking are the two most common activities for work site access. ATV's, snowmobiles, helicopters and boats are often used. The work is physical and can be tough. People who are successful at this kind of job enjoy the lifestyle, embrace physical and mental challenge and have a love of the out of doors, all year round.
